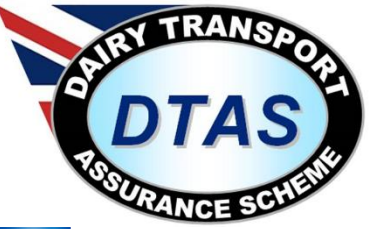




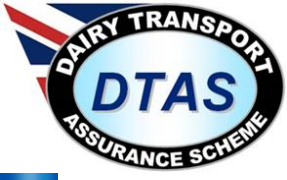

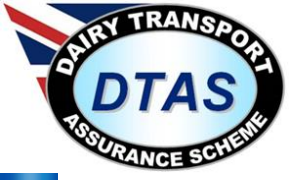
DTAS Awareness Courses - Summary 2023 / 24

- Quality assurance roles
- Other / new personnel who would benefit from a good understanding of the milk supply chain and DTAS
- Managers / Supervisors / Team Leaders / Lead Hands / Lead Drivers
- Drivers



DTAS Awareness Course – Why?

- General awareness and understanding
- Refresher training
- Haulier DTAS Champions / Internal Assessors



DTAS Awareness Course – Format & Content

- One day course
- Covers all DTAS Standards and what is required to comply
- Based at a milk haulage depot
- Includes practical elements
- DTAS self audit “competency” (A1.4)
- Opportunities to discuss practicalities and share good practice
- No exam!



DTAS Awareness Course (bespoke)

- Specific to your needs e.g. night shift
- Typically one day course
- Focus on what is applicable to your needs e.g.
 - DTAS Standards
 - Milk transport operation
 - Operating procedures
 - Milk samples / milk rejection etc.
- Includes practical elements
- Opportunities to discuss practicalities and share good practice

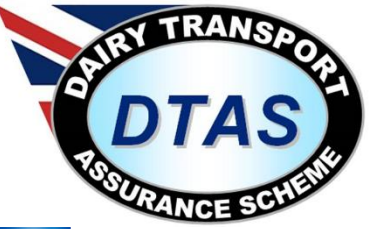

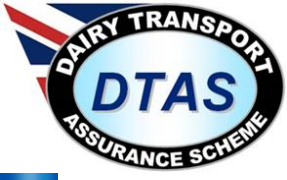
